HESLGB

Eligibility Criteria

Be a needy Malawian who has been admitted to pursue an accredited, generic, full-time degree program at a public/private university/college accredited by the National Council for Higher Education (NCHE)

Where NEEDY means:

- ❖ **A poor orphan.**
- ❖ **A poor applicant with disability or an applicant whose parents have disability and are poor.**
- ❖ **An applicant from a poor family.**
- ❖ **An applicant who has not inherited any property, estate or fortune**
- ❖ **An applicant from a low-income family earning the national minimum wage or below.**
- ❖ **An applicant who does not have any source of income to meet the cost of tuition, upkeep or stationery**



HESLGB

Eligibility Criteria

- ❖ **Have six credits in Malawi School Certificate of Education (MSCE) or its equivalent;**
- ❖ **Have verifiable conduct and commitment to studies**
- ❖ **Those repeating or weeded on academic grounds are withdrawn**



HESLGB

Private Higher Learning Institutions


- ❖ **Provided with 50% of annual tuition fees in the second semester**
- ❖ **This ensures equality because fees structure for private institutions is higher than public institutions**
- ❖ **Students from private institutions cannot apply for upkeep loans.**



Loan Processing Calendar



VETTING- Addresses possible errors of inclusion & exclusion that may be on the provisional list and remove all students who: **HAVE BEEN WITHDRAWN; HAVE DISCIPLINARY CASES; ARE REPEATING ARE PURSUING DIPLOMA/WEEKEND/MATURE ENTRY PROGRAMS AND ARE ON OTHER SCHOLARSHIP.**

LOAN DISBURSEMENT

- 1. Partial tuition** – disbursed in second semester upon verification of payment of the students' contribution.
- 2. Full tuition and upkeep** - 50% of the loan is disbursed in the 1st semester and the other 50% in the 2nd semester.

Terms and Conditions

- ❖ Providing false information is an offense.
- ❖ Loans are only available for the duration of the student's study program.
- ❖ If a beneficiary discontinues their studies before full disbursement, the remaining funds will not be disbursed.
- ❖ All loan beneficiaries must pay back their loan.



HESLGB

Common mistakes

- ❖ **Falsification of information-Age, Economic status, Details of parents/guardians**
- ❖ **Submission of incomplete loan applications**
 - **Without supporting documents**
 - **National ID**
- ❖ **Provision of wrong details as;**
 - **Account name**
 - **Bank name**
 - **Account number**
 - **Account details that are not personal**
 - **Physical address**
 - **Phone numbers**



Grants

- ❖ Provided to students in public institutions who perform exceptionally well (distinction).
- ❖ Students **MUST** pass the first year end-of-exams with a distinction
- ❖ HESLGB verifies with the institution of the grades before the grant is provided
- ❖ Grants are tenable only from the second year of study.
- ❖ If performance is sustained, the student continues to receive a grant which comprises tuition fees and upkeep



HESLGB

Loan repayment

- ❖ **Loans mature two years after successful and successful completion of one's study.**
- ❖ **Two years of grace period, no interest charged**
- ❖ **An extra five years provided to complete the loan repayment**
- ❖ **Loans can be paid directly to HESLGB or through monthly deductions from the employer, and an annual 15 percent interest is charged**
- ❖ **HESLGB is an information provider to the credit system in Malawi, which means that those who have not settled student loans will be listed as defaulters, making it difficult to access loans from commercial banks**




